# Comprehensive School Boundary Review

## Why a Boundary Review Now?

Fairfax County Public Schools is committed to ensuring that each and every FCPS student has equitable access to excellence and opportunities in alignment with the FCPS 2023-30 Strategic Plan.

This July, the **School Board approved Boundary Policy 8130**, which mandates that FCPS school boundaries be <u>reviewed every five years</u> going forward. Regularly reviewing and updating school district boundaries is a **best practice**. As part of this commitment, we are undergoing a **comprehensive boundary review** for the first time in nearly four decades.

- Uneven distribution of students due to under- and over-enrollment, resulting in temporary classrooms and modular buildings at many schools
- Suboptimal instructional program locations (taking students out of their high school pyramids)
- Lack of space to meet demand for additional programming, such as pre-k
- Increased travel times for students caused by current school boundaries
- Numerous split feeder schools and attendance islands
- Longer facility renovation wait times and high renovation costs

## **Benefits of a Boundary Review**

Balancing available capacity to optimize use of school facilities.

Minimizing travel time for students.

Establishing consistent attendance zones.

**Ensuring equitable access** to programs and facilities.

Optimizing budgets and reducing operating costs.

Improving student well-being and achievement.

## **FCPS Boundary Review Priorities**

The goal of the FCPS School Boundary review is to provide students the most effective and safest instructional experiences. Following **Policy 8130**, we shall prioritize the following criteria, in no particular order, when recommending individual school boundaries:



#### **Access to Programming**

Ensure equitable access to programs and facilities, and consider impact on school programs and populations.



#### **Proximity**

Promote contiguous attendance zones and maintain neighborhood groupings (to include condominium and apartment complexes) to eliminate and/or prevent establishment of attendance islands.



#### **Enrollment/Capacity**


Using student enrollment projections, balance available capacity and maximize efficient and effective use of school facilities for capacity utilization and program needs while eliminating or preventing the establishment of split feeders, whenever possible.




#### **Transportation**

Provide for walking and busing safety, limit transportation times, and ensure efficient transportation routes with attendance areas.

## **FCPS Boundary Review Process**







Community Meetings in both Phase 1 and Phase 2 will provide key insights into the community's priorities and needs.



The Superintendent's Boundary Review Advisory Committee will use community feedback and data analysis to help develop boundary scenarios and make recommendations to the superintendent.



The superintendent will consider recommendations from the Advisory Committee and present them to the School Board.

The Fairfax County School Board will review final recommendations and approve any boundary adjustments.

#### **Breakout Group: Guidelines**
